




#### To give you an accurate quotation, we'll need a site location plan. This should highlight clearly where you'll carry out the proposed works, and the map's scale:

## **Disconnections visual**

If your supply is fed underground the service cable will have to be isolated externally. This will involve a small excavation outside your property where our Jointer can safely expose & cut the cable.

If your supply is fed overhead the service cable will be terminated at the pole and the redundant cables removed.


#### 2. What are Ordnance Survey coordinates?

These are the grid coordinates for your location on a map. You can find them easily by using a grid reference finder online, such as:

- 3. We can provide 2 different types of Quotation:
- Formal A formal quotation is an offer from SP Energy Networks to you and is valid for a period of 3 calendar months. Find out more at: sppowersystems.co.uk/NetworkConnections
- Budget We can provide a basic priced estimate of the costs that would be associated to your disconnection requirements with just a small amount of information. Note that this is a guide only and if you wanted to progress to us carrying out the works then we would need to create a formal Quotation.

#### 4. What is a Meter Point Administration Number (MPAN)?

An MPAN is a unique number associated with a property which identifies the electricity supply point. An MPAN can be found on the electricity bill issued by your Electricity Energy Supplier. It forms part of the Supply Number or 'S' number.



(MPAN highltighted in yellow)

13 = Cheshire, Merseyside, North Wales & North Shropshire.

18 = Central & Southern Scotland.

You are in our area if the distribution ID starts with an 18 or 13. If it does not please visit the energy networks association website to find your network operator.

If you cannot find the MPAN for a premise please contact the Meter Point Administration Service (MPAS) team on 0330 1010 300 for assistance.

#### 5 What is included in the cost?

You will receive an itemised breakdown of the total cost of works at the back of your quotation, your designer will be happy to talk you through this.

#### 6. What am I responsible for?

You are responsible for providing the MPAN numbers of all supplies requiring disconnection, a site location plan and site access on the agreed date of disconnection.

#### 7. Following the disconnection I will require a temporary site supply?

Please contact us to discuss, it may be guicker and more cost effective to arrange moving your supply position.

#### 8. How can I get a copy of the existing electrical network drawings?

To obtain a copy of our existing electrical network drawings please send a location plan of the required area and/or the address and postcode together with your correspondence details to the following email address:

#### 9. Who will remove the electricity meter?

SP Energy Networks doesn't remove electricity meters, so when you've accepted the quotation we will inform your Electricity Supplier for them to remove your meter.

#### 10. The Customer or Contracted Party are liable for any ongoing payments or associated refunds and will at all times remain the Customer in relation to the Connection Offer.

This means if you are a 3rd party acting on behalf of a Customer but the Customer is accepting the quote, then we will need their information to enter into a contract with that Customer (Contracted Party). Or, if you are a 3rd party acting on behalf of a Customer and you have authority to accept this quotation, the Customer (Contracting Party) must complete the 'Letter of Authority' attached to the Quotation. Variation guotes, tax invoices & refunds can only be sent to the Contracted Party whom we have issued the quote, regardless who has made the payment.

#### 11. Excavation and Reinstatement

If you choose to arrange excavation and reinstatement you will be responsible for the liaison with the relevant local authority, to obtain the relevant permits, street works license's (section 50) and to comply with the necessary legislation and conditions as required by the relevant local authority including, the New Roads and Street Works Act 1991. All excavations shall conform to NJUG 7 wherever possible.

Prior to any works, we will complete an inspection of the excavation and to view the evidence that the necessary licenses / permits have been obtained. It will be your responsibility to pay any additional costs to the local authority incurred in obtaining the necessary permits, licenses etc to enable you to complete the necessary excavations works.
